NOVADECI POLICIES GOVERNING MEMORIAL LOT SALE

All policies covering Installment of lots are herein enumerated:

I. Member's Application Form [Easy Invest Memorial Plan Form] and Loan Application

All necessary information in the member's application shall be filled-up properly and member must affix his/her signature on the space provided together with the Loan Application.

II. Term of Payment

The member shall opt for the term of payment, available in 12 months; 24 months; 36 months; 48 months; and 60 months to pay.

III. Installment Scheme

Upon signing of the agreement the member shall put-up the initial one [1] month installment payment based on the term of payment opted. The next installment payments shall commence 30 days thereafter until full payment on contract price is made.

IV. Grace Period

A grace period of 10 days for the whole term of the loan is accorded to the member. In the event NO INSTALLMENT payment had been made, a payment shall be charged to the member.

V. Penalty

A penalty of two [2%] percent per month, based on the installment scheme shall be charged to the member. The penalty shall accumulate accordingly in consonance with the member of unpaid installment payment.

VI. Interment

While the lot chosen is on Installment, the member shall pay in full the principal amount of the lot before interment. Should the member dies during the installment period, the balance shall be considered paid, after one [1] year of installment period. As indicated in the installment scheme, installment payments are the lot only, exclusive of the interment fee.

VII. Foreclosure

This proceeding is an exclusive option of NOVADECI, before any foreclosure action shall be effected, NOVADECI shall send [3] reminder letters or advice to the member to accord him the opportunity to update the arrearages, however, should no response had been received, and NOVADECI shall affect the foreclosure.

VIII. Voluntary Surrender

It is interpreted that once the member voluntary surrender his right over the lot purchased on installment, NOVADECI shall rescind the agreement. There will be no refund of payment made by the member.

IX. Certificate of Ownership

Upon full payment of the lot purchased, a **Certificate of Ownership** shall be issued in the name of the member.
